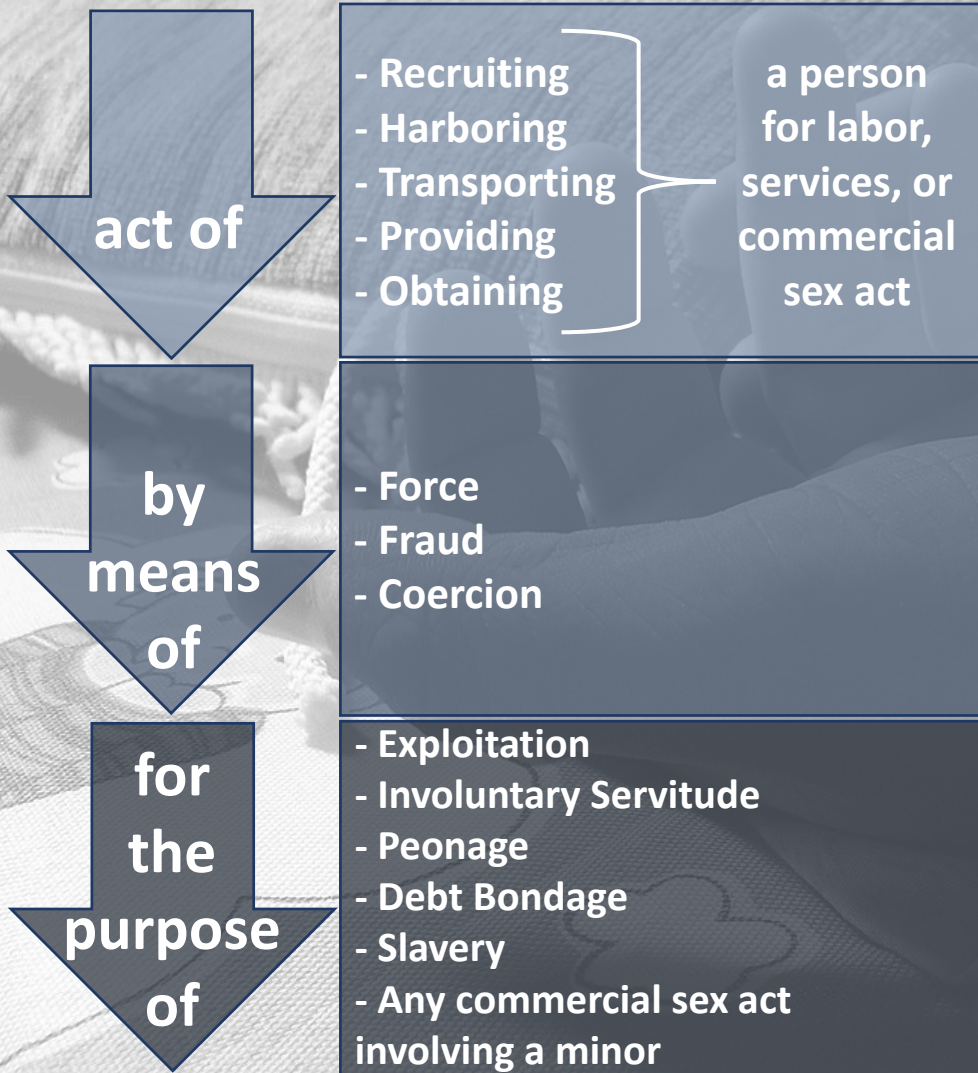

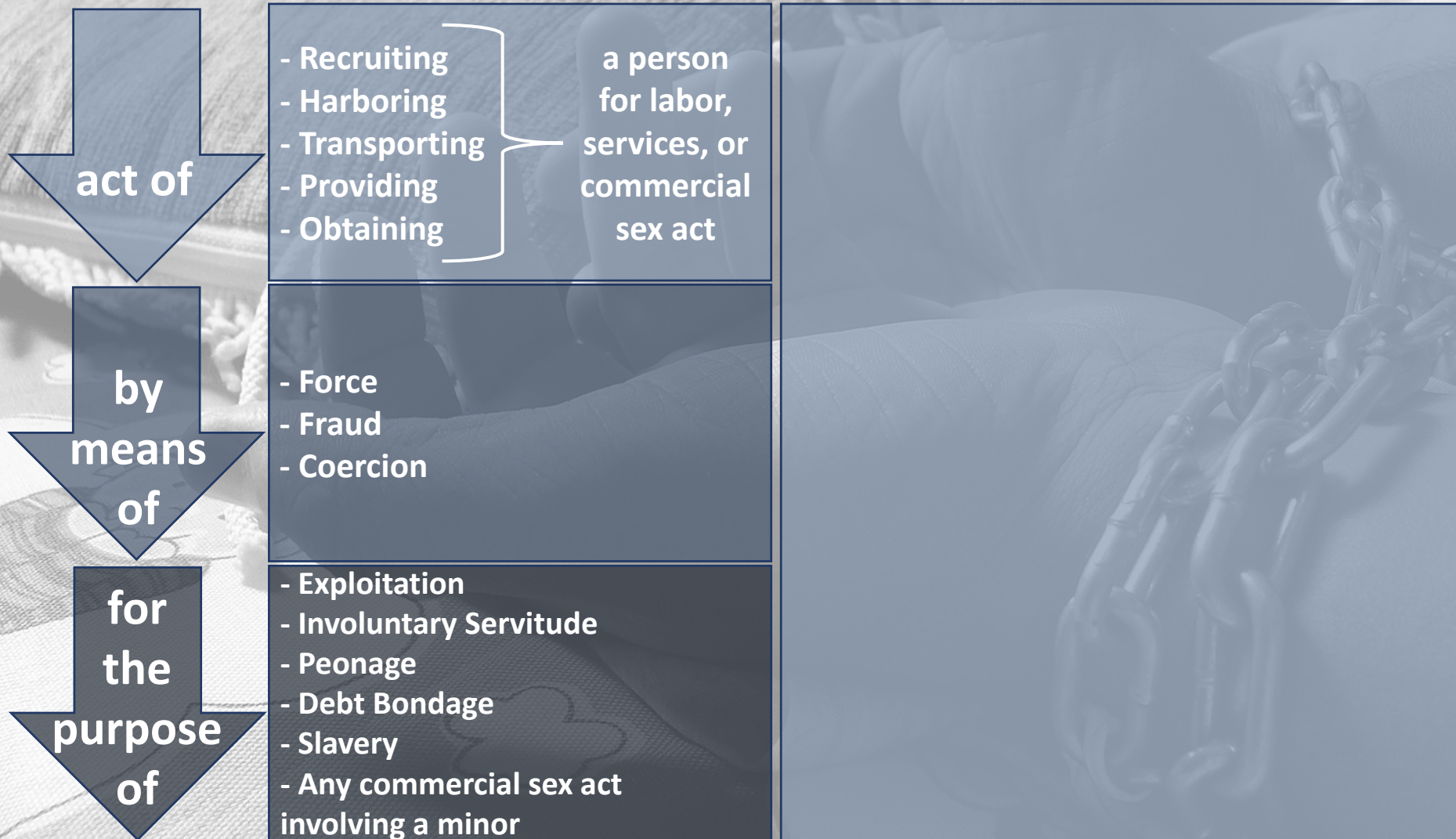

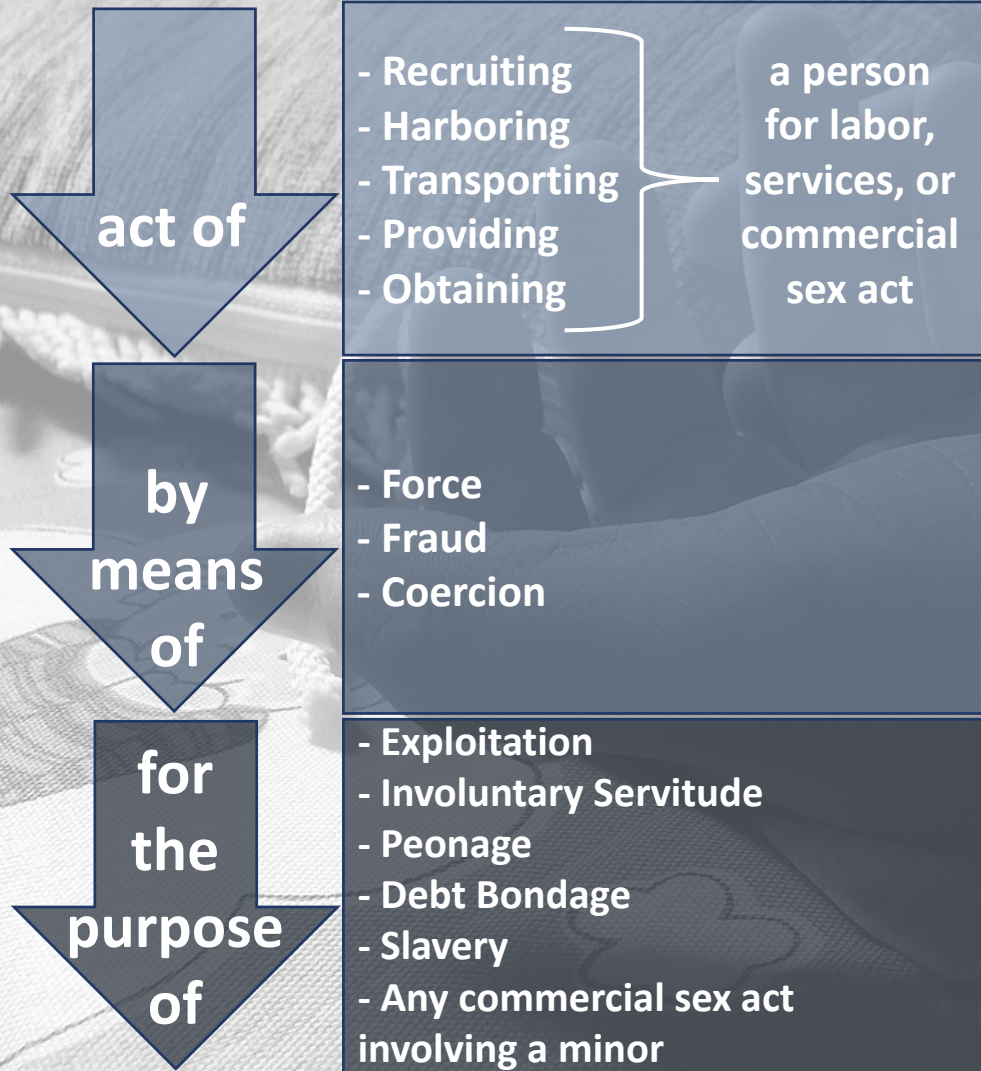

For what purpose are victims controlled?

Involuntary Servitude



Individuals subjected to involuntary servitude are held against their will and forced to work, often under a threat of violence to themselves or their families.

Debt Bondage



Victims of debt bondage are typically required to work for minimal wages in order to repay an extreme amount of money in exchange for a service, such as transportation or recruiter fees for a job.

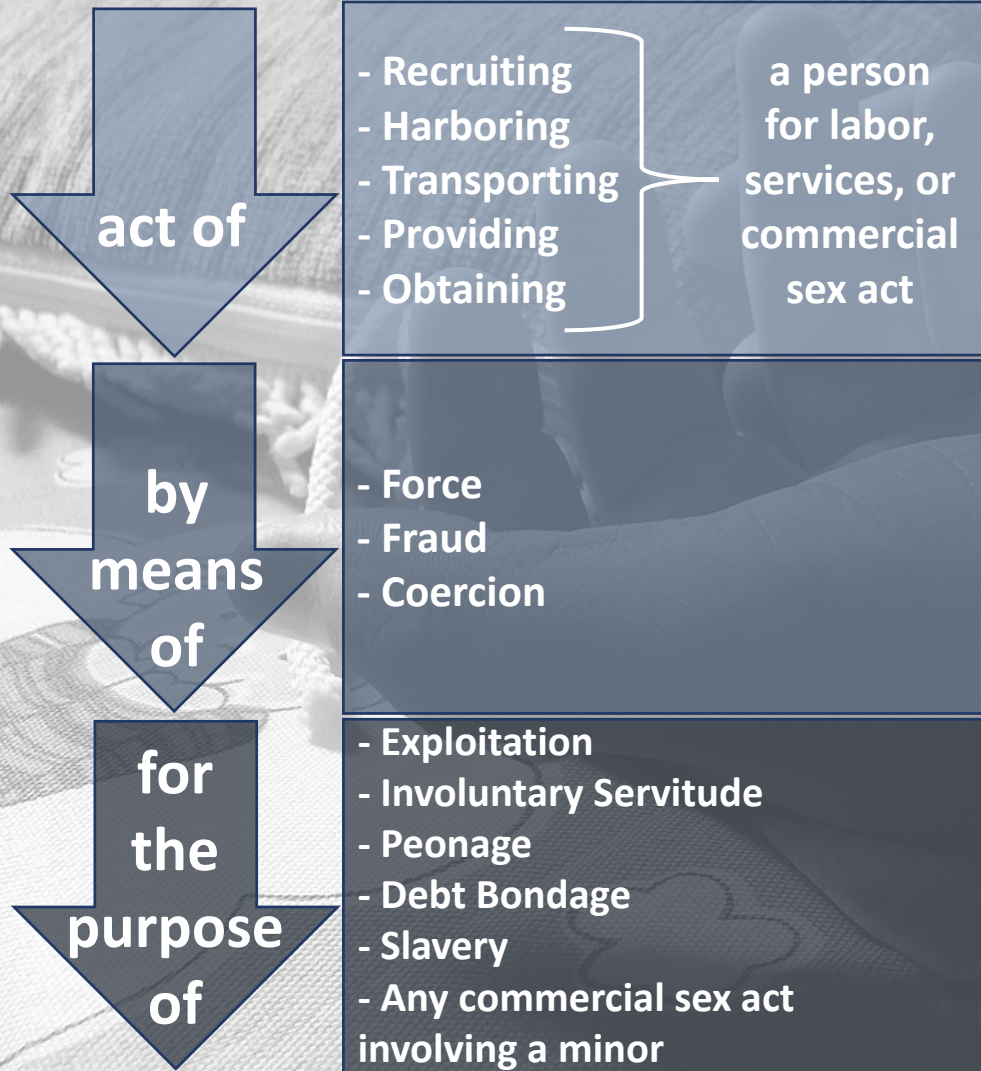

How are victims exploited?

Sexual Exploitation



Trafficking also transpires for commercial sexual exploitation. This encompasses street prostitution, massage parlors, brothels, pornography, live-sex shows, and sex tourism.

Traffickers coerce, force, or deceive victims into performing such commercial sex acts.

Forced Labor



Forced Labor can also occur in agricultural, domestic service; manufacturing, and janitorial services; hospitality industries; construction; health and elder care. Forced Labor Victims are Often lured by promises of steady work and a better life, victims are robbed of their freedom, and forced to work in factories, farms, restaurants and small businesses – for little or no money.

Under Button – Red Flags of Human Trafficking

Look for **Red Flags** & Indicators Which May Include:

- Exhibiting changes in behaviors or school participation.
- Having a history of homelessness or running away from home.
- Revealing signs of abuse or inattentive caregivers.
- Displaying a heightened sense of duty or obligation to family, has unreasonable or inappropriate chores or duties.
- Works for little or no pay, or employer keep identification documents and/or confiscates wages.
- Accumulates debt to employer.
- Exhibits sexual behavior that is high risk and/or inappropriate for his/her age.
- Has an explicitly sexual online profile and/or profound knowledge of the commercial sex industry.
- Engages in sexual activity in exchange for money or anything of value.

Assess Safety and Needs

Speak to the youth in a private setting, and follow his/her cues

- Is it safe for the youth to talk right now?
- Is anyone watching, listening, calling, or texting the youth?
- Is the controller present or nearby?
- Does the controller know where the youth attends school or lives?
- What would happen if the youth tried to leave the controller?
- Is the youth or a family member in danger?
- Does the parent(s)/legal guardian(s) know about the situation?

Basic Trafficking Assessment

- How did you meet your boyfriend/find out about your job?
- Have you ever tried to break up with your boyfriend/leave your job? Is anyone preventing or threatening you?
- Do you want help leaving?
- Are your family members or friends in danger if you try to leave?
- Have you ever been forced to do work that you didn't want to do?
- Were you ever lied to about the type of work that you would do?
- Has anyone ever given you money or offered it to you for having sex? Does anyone force you to have sex?
